



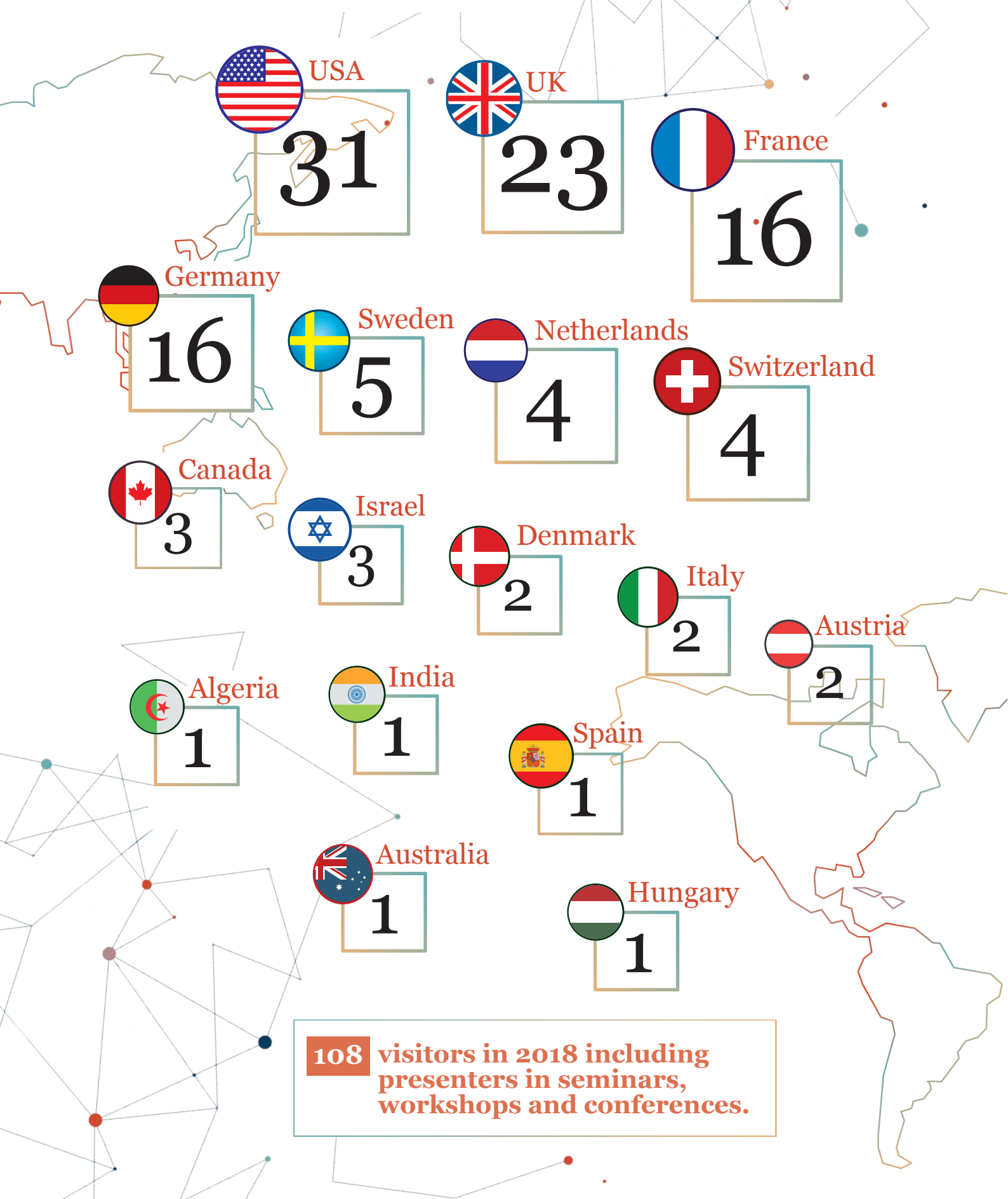

EDITORIAL •

2018 marked the end of the independent funding of IAST from the «Laboratoires d'Excellence» initiative of the French government and the launch of the new «Ecole Universitaire de Recherche» of TSE and IAST.

This new research school aims to increase the quality and interdisciplinary focus of the research training of economists at TSE, as well as to bring doctoral students in other social sciences for periods of research training in Toulouse. Within this school IAST will maintain its own autonomous budget and continue to recruit researchers at the postdoctoral, assistant professor and senior researcher level. Our core funding is assured until 2028, so although we shall need to continue our search for longer term funding we shall be able to focus on long-run research questions without needing to assure our security in the immediate future.

It is both an exciting and a daunting time to be doing frontier research in social sciences. Political developments around the world have placed researchers and technocrats on the defensive, both with respect to the willingness of citizens whose taxes fund their work, and with respect to the authority that the scientific method once commanded. There are

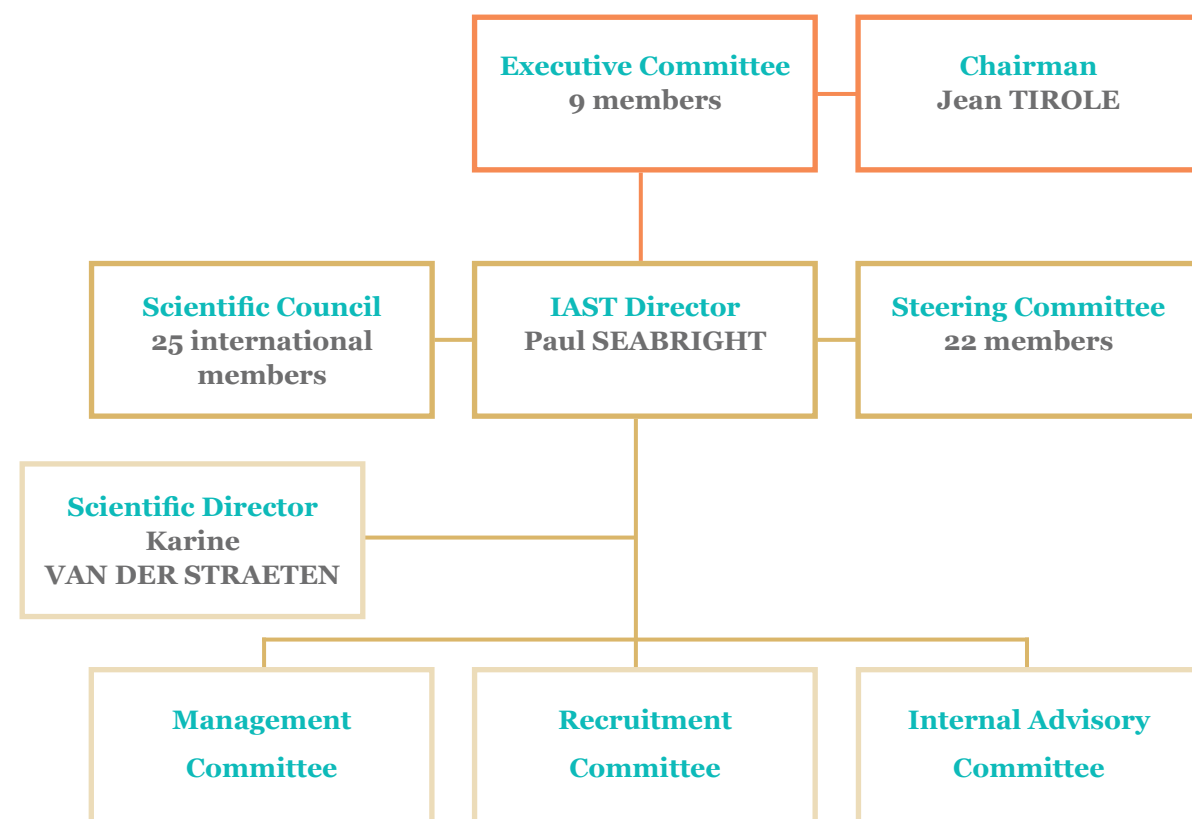
some good things to come out of this: researchers are increasingly realizing that we cannot rely on the deference of citizens to fund our research, and are taking the effort to explain to a wider public the reasons why rigorous evidence-based policy yields better results than the unfiltered gut-instinct of political decision-makers. But it can also make it harder for our voices to be heard over the surrounding noise. Some influential politicians have expressed open contempt for experts. In this setting it is more important than ever for social scientists to work together to bring their different disciplinary skills to bear on common challenges. We look forward to the coming years with both concern and excitement - it is not going to be a dull time to study the development of human society. ■

IAST Governance ■



IAST operates as a sheltered foundation under the aegis of the Jean-Jacques Laffont - TSE Foundation.

It has a scientific council composed of 25 members and is governed by an Executive Committee (COMEX), composed of 9 members: the two founding members (Toulouse Capitole University and the collegium of economic partners), two representatives

of the collegium of public partners, one representative of IAST researchers, one representative of the Jean-Jacques Laffont - TSE Foundation and three qualified members. The COMEX met twice in 2018, on May 30 and December 04.

Daily management is currently led by the Director (Paul Seabright) assisted by Delphine Pouts, with the administration under the management of Joël Echevarria, and the scientific program under the direction of Karine Van Der Straeten.

2018 saw the dissolution of the disciplinary programs and establishment of two new committees: the management committee with 5 members, and the recruitment committee with 7 members. On December 04, 2018, Jean Tirole resigned from his position as chairman of the Jean-Jacques Laffont Toulouse School of Economics Foundation, sister institution to IAST. As a consequence, a vote is to be held of the COMEX of IAST in June 2019 to elect a new chairman for IAST.

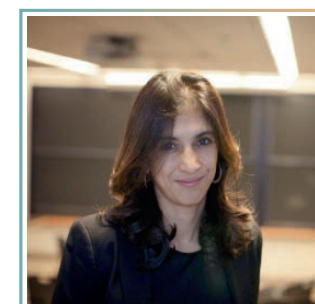

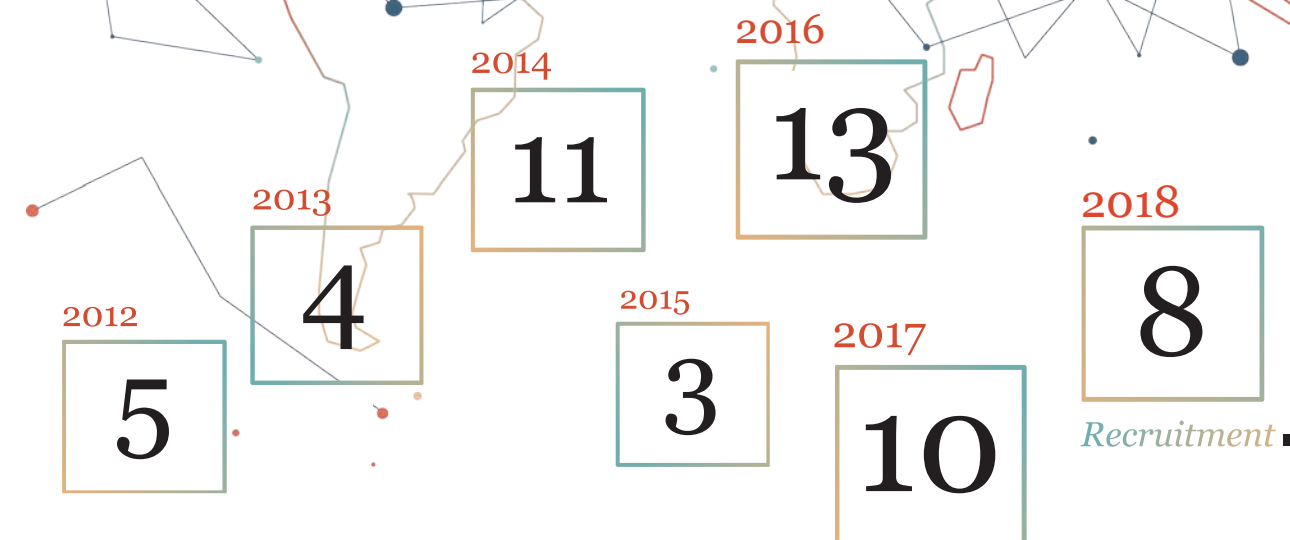

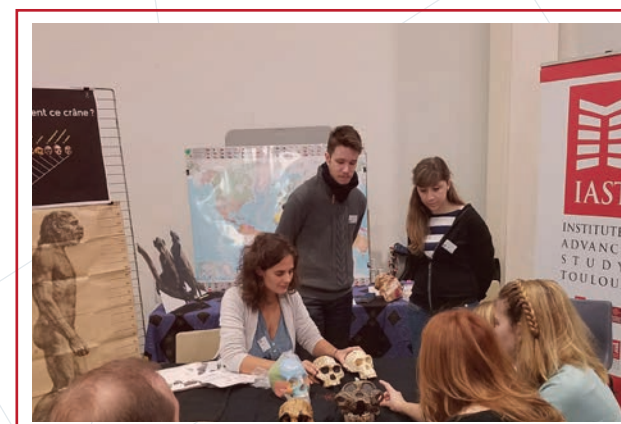

MOHAMED SALEH

COLE PRIZE, ECONOMIC HISTORY ASSOCIATION

Mohamed Saleh, historian and assistant professor at Toulouse School of Economics and IAST, has been awarded the Economic History Association's Cole Prize for the best article in 2018 «On the Road to Heaven: Taxation, Conversions, and the Coptic-Muslim Socioeconomic Gap in Medieval Egypt» published in the Journal of Economic History. Devoted to the multidisciplinary study of history and economics, the journal awards each year this prize for the best article in the previous year's volume of the Journal.

SCIENTIFIC ACTIVITIES IN 2018

ANTHROPOLOGY ■ ■

IAST anthropologists address broad questions that can situate anthropology in a key position within the social and life sciences.

In 2018 IAST and IAST-affiliated anthropologists continued publishing their research in top-tier peer-reviewed scientific journals, including *Science*, *Nature Communications*, *Nature Human Behaviour*, *Proceedings of the Royal Society B: Biological Sciences*, *American Journal of Clinical Nutrition*, *American Journal of Physical Anthropology*, *American Journal of Primatology* and *Human Nature*, among others. Themes addressed in these publications were diverse, spanning current debates in the evolutionary behavioural and social sciences. Examples of these themes

include factors underlying sexual conflict in humans and nonhuman primates, the nature, pace and implications of nutrition transition in the developing world, biomechanical constraints underlying human growth patterns, and genetic evidence for early animal domestication. Some of this research was featured in international media outlets including *Newsweek*, the *Canadian Broadcast Corporation* and *New Scientist*. In addition to producing a stream of high-quality journal articles, a new IAST research fellow, Francesca de Petrillo, co-edited an interdisciplinary book entitled, *“Evolution of Primate Social Cognition”*. IAST anthropologists were awarded several prestigious external grants, from the US National Science Foundation and US National Institutes of Health-National Institute on Aging, to study development and aging of the skeleton and brain.

They participated in several international workshops and conferences in 2018, including “Language acquisition across cultures”, hosted by the Max Planck Institute (MPI) for the Science of Human History in Jena (organized by Heidi Colleran, a former IAST research

fellow currently at MPI), “Field site management”, hosted by the MPI for Evolutionary Anthropology in Leipzig, “Harmful Practices”, hosted by the Broom Center for Demography at the University of California-Santa Barbara, and annual conferences of the American Association of Physical Anthropologists and International Primatological Society. IAST also hosted a workshop entitled “Origins of our Moral and Political Ideologies and Preferences” that featured anthropologist Cristina Moya (University of California-Davis). Jonathan Stieglitz co-organized a workshop with former IAST research fellows Jeanne Bovet (Boston College) and Boris van Leeuwen (Tilburg University) on the “Developmental Origins of Economic Preferences”. IAST anthropologists were also invited to present their research at seminars worldwide, including at the American Museum of Natural History, Arizona State University, Chapman University, Stony Brook University and Université Paris II.

IAST welcomed two visiting researchers for an extended period, Nell Gabiam (Iowa State University) and Marco Campenni (University of Exeter), to present and pursue their research on refugees displaced by war and risk pooling networks, respectively. IAST also hosted a seminar by human behavioural ecologist Mhairi Gibson (University of Bristol) on social norms underlying female genital cutting.

IAST anthropologists also participated in various internal seminars (e.g. on sexual conflicts in baboons, and on reconstructing population histories in Madagascar) and participated in local public outreach events, including *Scientilivre*.

Aside from advancing ambitious research agendas, IAST anthropologists remain actively involved in teaching Masters- and PhD-level courses in Behavioral and Experimental Economics at UT1, as well as a Masters-level course in evolutionary medicine at the Faculté des Médecine de Toulouse (UT3).

Looking towards the future, from April 23-26 in 2019, IAST will co-host the 14th annual conference of the European Human Behaviour and Evolution Association (EHBEA). This conference will bring together around 250 evolutionary social and behavioural scientists from across the world. Conference plenarists will include Etienne Danchin (Emeritus CNRS Research Director, Laboratoire Évolution & Diversité Biologique), former IAST research fellow Luke Glowacki (Penn State University Department of Anthropology), Claudine Junien (Emeritus Professor of Medical Genetics, Faculté de Médecine Paris-Ouest), Daniel Lieberman (Harvard University Department of Human Evolutionary Biology), Richard McElreath (MPI for Evolutionary

Anthropology), Anne Pusey (Duke University James B. Duke Professor Emerita of Evolutionary Anthropology), and Jean Tirole (Toulouse School of Economics). To co-host this conference IAST has received generous financial support from local and international sponsors including Cambridge University Press, Galton Institute, Région Occitanie, and Toulouse Métropole.

Lastly, IAST is tremendously proud of its former members, Luke Glowacki, Heidi Colleran and Alice Baniel, for recently obtaining positions at Penn State University (Assistant Professor of Anthropology, Glowacki) the MPI for Evolutionary Anthropology in Leipzig (Research Group Leader, Colleran) and at Stony Brook University (Postdoctoral Researcher in Anthropology, Baniel).

BIOLOGY ■ ■

Since the inception of the Biology Program at IAST, the overarching objective has been to promote discussions between economists and biologists, and to some extent also with anthropologists.

This focus is very natural, given that within each of these disciplines there are researchers who seek to enhance our understanding of the ultimate forces that drive (human) behavior, and the consequences thereof for societies. Furthermore, economists, biologists and ecologists have complementary tools when it comes to analyzing issues such as ecosystem management, and the regulation of markets for pharmaceutical drugs whose consumption may cause drug resistance. A variety of activities have been undertaken to further this objective.

The following external seminar speakers were invited to speak at the IAST seminar series and were particularly relevant for the Biology activities: Hannes Rusch (Philipps-University Marburg), Michael Hochberg (ISEM Montpellier, CNRS), Mhairi Gibson (Bristol University), Jacob Weisdorf (University of Southern Denmark), Joshua Tybur (VU Amsterdam), Denis Pierron (AMIS Toulouse), Leonardo Trasande (New York University Medical School). The 6th Economics and Biology Workshop “Evolution, Cognition, and Rationality”

took place in May and brought together internationally renowned researchers in economy, biology, cognitive sciences and computer sciences among which featured : Immanuel Bomze (University of Vienna), Yuval Heller (Bar-Ilan University), Erik Mohlin (Lund University), Arthur Robson (Simon Fraser University), Ariel Rubinstein (Tel Aviv University), Aldo Rustichini (University of Minnesota), Joanna J. Bryson (University of Bath, Princeton University), Noam Brown (Carnegie Mellon University), Iain Couzin (University of Cambridge), Audrey Dussutour (CNRS - University Toulouse III), Cecilia Heyes (University of Oxford), Peter Gärdenfors (Lund University), Alex Kacelnik (University of Oxford) and Marc Mézard (ENS - Paris Sud University). The two-day event included 14 plenary presentations, a poster session for a total of 9 post-docs and PhD students. The event brought together researchers from a large of array of sciences from both the local and international scene. IAST was honoured to welcome two long visitors in its Biology discipline: Michael Hochberg (ISEM Montpellier CNRS) and Jörgen Weibull (Stockholm School

of Economics). Part of the success of the biology field relies on the collaboration with a number of key partners in the Toulouse region, including Étienne Danchin, Monique Gardes, Christophe Thébaud, and their colleagues at EDB (Évolution et Diversité Biologique, Université Toulouse Paul Sabatier), that of Jean Clobert, Claire de Mazancourt, Michel Loreau, Alexis Chaine and their colleagues at SETE (Station d’Écologie Théorique et Expérimentale du CNRS à Moulis), as well as that of Éric Crubézy, Patricia Balaesque, Morgane Gibert and their colleagues at AMIS (Anthropologie Moléculaire et Imagerie de Synthèse).

In September 2018, two biologists joined the institute: Sabine Nöbel (PhD Biology, University of Siegen) and Vivek Venkataram (PhD Biology, Dartmouth College) both appointed to IAST Research Fellow positions.

The multi-disciplinary teaching program in Economics and Ecology, partly funded by IAST, which was launched in September 2017, opened again in the 2018-2019 academic year. This program, which is a path in the M2 ERNA (Environmental and Natural Resource Economics), is taught by ecology faculty from the University Paul Sabatier (from the research groups EDB and SETE) and by economics faculty from the Toulouse School of Economics. The diversity of methods and skill sets of the current researchers with interests in history reflects the interdisciplinary approach of IAST.

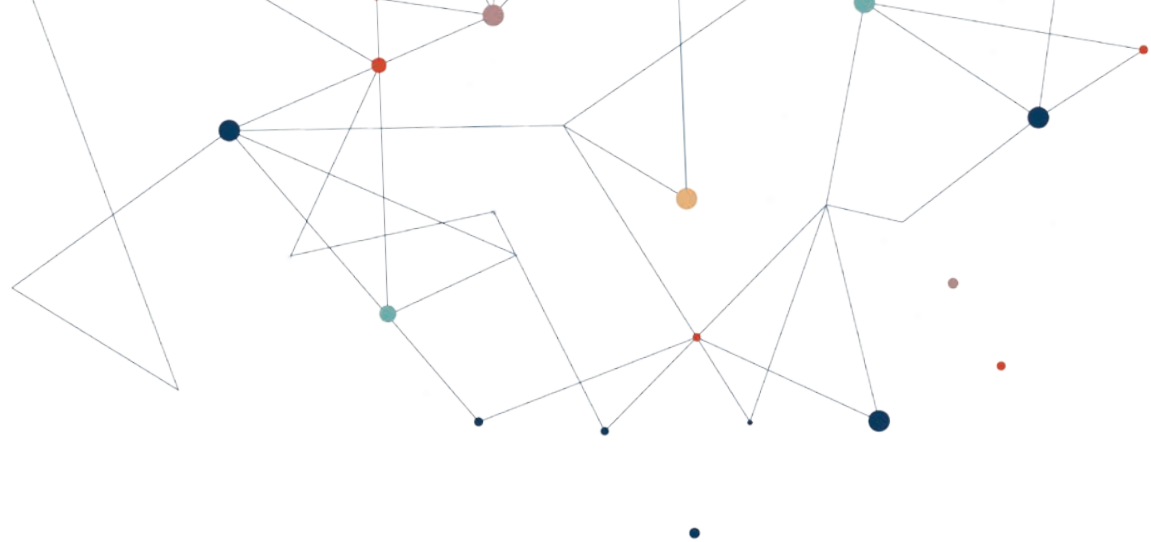


IAST hosted several events in history in 2018 among which a two-day workshop in June entitled "Information, Communication and Knowledge in Historical Perspective". This workshop featured a number of researchers working at the intersection of social sciences and history including Nile Green (UCLA), Gerben Bakker (LSE), Erica Charters (Oxford), Hansun Hsiung (MPG), Mara Squicciarini (Bocconi), Bronwen Everill (Cambridge), Ilham Khuri-Maqdisi (Northeastern), Julia Cagé (Sciences Po Paris), and Aldon Morris (Northwestern).

The IAST General Seminar featured an economic historian, Jacob Weisdorf (University of Southern Denmark) who presented his paper entitled, "Rising Wages, Family Planning, and Economic Development: Evidence from the Population History of England, 1541-1871." The IAST Tuesday Lunch Seminar featured several seminars on the topics of history. The speakers included: Kathryn Schwartz (IAST research fellow) on "Print: Agent or Object of Change?," Mohamed Saleh (TSE and IAST Assistant Professor) on "Taxing Identity: Fiscal Policy and Conversions in Early Islam,"

(joint with Jean Tirole), and Victor Gay (TSE and IAST Assistant Professor) on "Shocking Culture: The Enduring Impact of World War I on Attitudes towards Gender Roles."

A joint IAST-TSE recruitment was offered to Victor Gay as a Tenure-Track Assistant Professor of Economics. Victory Gay is an economic historian with a PhD in economics from the University of Chicago. Furthermore, Sreemati Mitter, a former IAST research fellow in history, came back to IAST in September 2018 for one more year of her research fellowship. The diversity of methods and skill sets of the current IAST and TSE researchers with interest in history (Nicolas Crawford, Victor Gay, Gabriel Mesevage, Sreemati Mitter, and Mohamed Saleh) reflect the interdisciplinary approach of the institution.

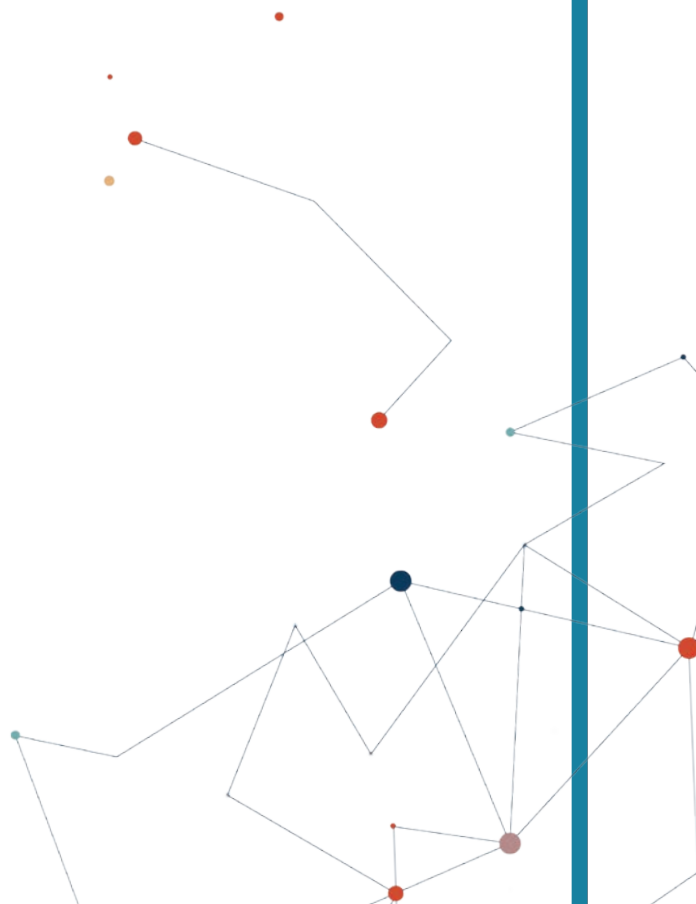

The scientific contribution to the IAST in the law discipline is in law and social science (in particular economics) and it is primarily committed to two strands of research: (i) the positive economic analysis of law, with a specific focus on the firm value implications of corporate governance; and (ii) law and philosophy, with a specific focus on the origins of morality and formal legal rules and the epistemology of judicial decision-making.

In 2018, three interdisciplinary courses were offered by Simone Sepe : Law and Economics of the US Antitrust Law (TSE-M2); Principles of Law and Economics (Law-M1-MIEL); Finance - Law and Finance Module (Ph.D. Finance - Toulouse Business School and DEEQA-TSE). The idea of offering Law and Economics of the US Antitrust Law is motivated by the fact that cooperation between the American federal antitrust authorities and the European Directorate of Competition is now well established and continues to grow apace. The seminar then aims at introducing students to the basic principles of American antitrust law. Moreover, a long seminar session in Game Theory and the Law was offered to M2 law students. Starting from 2019, a new Law-M1-MIEL students course will be delivered «Law and Economics of Intellectual Property».

On June 18-19, 2018, Simone Sepe and Thomas Christiano (IAST fellow) co-organized the Second IAST Conference in Philosophy and the Social Sciences on The Philosophical Foundations of the Economic Analysis of Law. The conference hosted several external speakers and discussants, including Bruce Chapman (University of Toronto), Ugo Pagano (University of Siena), Arnaud Raynaud, (Paris - Dauphine Law School), Daniel Markovits (Yale Law School), Elias Khalil (Monash University), Lewis Kornhauser (New York University Law School), Richard Brooks (New York University Law School). In addition, several scholars from the Toulouse community had an active role at the conference, including Lucien Rapp (Toulouse Law School), Mathieu Carpentier (Toulouse Law School), Michael Becher (IAST), Grégory Kalfleche

(Toulouse Law School), Andrea Attar (TSE - University of Tor Vergata), Hannah Simpson (IAST), Daniel Chen (IAST), Paul Seabright (IAST), Gerard Hertig (ETH Zurich), and Thomas Christiano (IAST - University of Arizona). The economic analysis of law has become a major approach to the law (mainly in private law) in the United States, the central aim of the conference was to discuss the jurisprudential and political philosophy foundations of such an approach. Simone Sepe and Thomas Christiano co-hosted a reading group with the IAST in December 2018, on the evolution of morality.

Political scientists studying at IAST are joined by theoretical and empirical economists, economic historians and other social scientists to raise fundamental questions concerning the functioning and development of states, political institutions, and the links between citizens and rulers.

At IAST, these questions are addressed not only by political scientists, but also by theoretical and empirical economists, economic historians and other social scientists. This is natural because any market system is embedded in a political system, and the development and stability of political institutions is interrelated with economic and societal change. Understanding the micro foundations of human decision making and cooperation is also crucial for the study of politics. Supported by the institute's Center for Analytical Political Science (CAPS), the goal of IAST is to foster an interdisciplinary dialogue on these issues motivated by shared questions and based on a common analytical approach. While the methods or cases may vary, this is fruitful and thought provoking.

In 2018, political scientists at IAST organized two conferences, welcomed an impressive number of seminar speakers and fostered collaborations with TSE and other research institutions in France, Europe and the United States.

In the General Seminar, Catherine De Vries (University of Essex) presented research on "When the Money Stops: Declines in Financial Remittances and Incumbent Approval in Central Eastern Europe, the Caucasus and Central Asia"; Mark Kayser (Hertie School of Governance) on «Accuracy and Bias in Media Coverage of the Economy: An Analysis of Sixteen Developed Democracies»; Eric Dickson (NYU) on «Political Correctness and Productive Criticism»; and Miriam Golden (UCLA) presented ongoing work on «Re-election, Political Selection, and Development.»

Political scientists at IAST also continued to jointly organize talks on political economy topics with the Development, Labor and Public Policy (DLPP) seminar at the TSE. This initiative leverages and strengthens synergies between scholars at IAST and TSE. The speakers included Vincent Pons (Harvard Business School) "Expressive Voting and Its Cost: Evidence from Runoffs with Two or Three Candidates", Salvatore Nunnari (Bocconi University) «A Model of Focusing in



Political Choice» and Horacio Larreguy (Harvard University) «Who Debates, Wins? Experimental Evidence on Debate Participation and Radio Broadcasting in a Liberian Election?».

The fifth IAST-TSE Conference in Political Science and Political Economy took place in March. The overarching theme was "The Politics of Social Identity". Class, ethnicity, gender, language, religion, and other ways in which individuals identify themselves and people around them are defining features of politics, conflict, and inequality in many countries. This two-day event included 11 presentations that explored the interplay between social identity and political competition and how it shapes cooperation, elections, representation, and well-being around the globe. External speakers included Simon Chauchard (Dartmouth), Elias Dinas (EUI), Jenn Larson (NYU), Yotam Margalit (Tel Aviv University), Cecilia Hyunjung Mo (UC Berkeley), Solédad Prillaman (Oxford), Amanda Leah Robinson (Ohio State), and Moses Shayo (Hebrew University).

In early July, IAST hosted the second IAST-Sciences Po Paris conference in Political Economy and Political Science

(co-organized with former Research Fellow Patrick Le Bihan from Sciences Po Paris). This two-day event included a mix of speakers from IAST (Michael Becher, Raymond Duch, Carlo Horz, Irene Menendez Gonzalez, Lucas Novaes), TSE (Emmanuelle Auriol, Jean-Paul Azam, Daniel Chen) and Sciences Po Paris (Sylvain Brouard, Olivier Godechot, Emeric Henry, Martial Foucault, Romain Lachat, Daniel Rubenson).

In the fall, new Research Fellows Leah Rosenzweig (PhD from MIT) and Saurabh Pant (PhD from Princeton) took over the organization of the bi-weekly political economy working group, which provides a valuable venue to discuss work in progress.

Eric Dickson, Associate Professor of Politics at NYU, took up a two-month visiting fellowship in May and June. As usual in the last years, we were also fortunate to have longer-term visitors David Austen Smith (professor of political science and economics at Northwestern University and IDEX chair at the University of Toulouse) and Raymond Duch (political science professor at Oxford University).

Media exposure and debate among the general public, experts, institutions and corporate sector on the ethics and morals of self-driving cars brought a great amount of highlight to the work of psychologists at IAST in 2018.



In 2018 psychology researcher Jean-Francois Bonnefon, continued his research on the morality of robots and machines. His paper *The Moral Machine* experiment (published in Nature) summarizes results from the «Moral Machine», an online experimental platform designed to explore the moral dilemmas faced by autonomous vehicles. This platform gathered 40 million decisions in ten languages from millions of people in 233 countries and territories. The results provide unique evidence of cross-cultural ethical variation. The paper was discussed widely in the media, among others in the «New Yorker», the «Washington Post», «Le Monde», French television «le Quotidien» and radio show «France Info».

The importance of considering emotions for economists, was discussed by Astrid Hopfensitz during a podium exchange at the Pompidou Center in Paris, during a two-day event on «the power of emotions». The event brought together researchers and artists exploring the power and possibilities of emotions.

The psychology program recruited two new post-doctoral fellows in 2018: Bence

Bago who studies cognitive psychology and decision-making and Francesca de Petrillo whose research examines the evolutionary origins of human judgment and decision-making, by comparing how humans and other primates acquire and process information, and make decisions. Lauriane Rat-Fischer left IAST in June to take up a research and a teaching position in Psychology at the University of Paris, Nanterre.

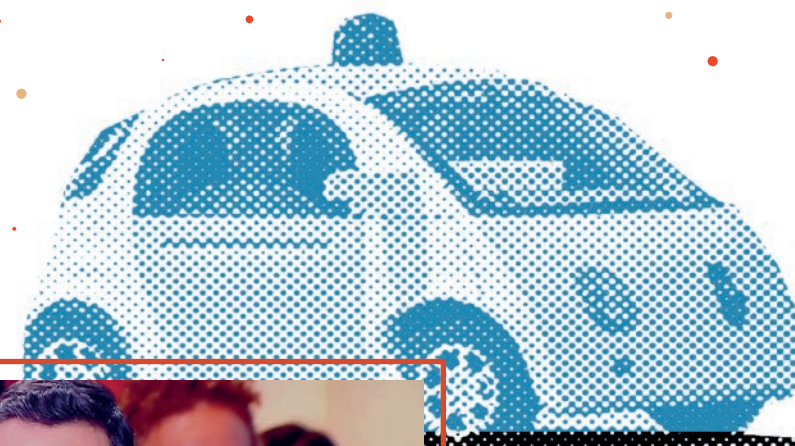
IAST researchers exchanged with a number of external psychologists through various events. 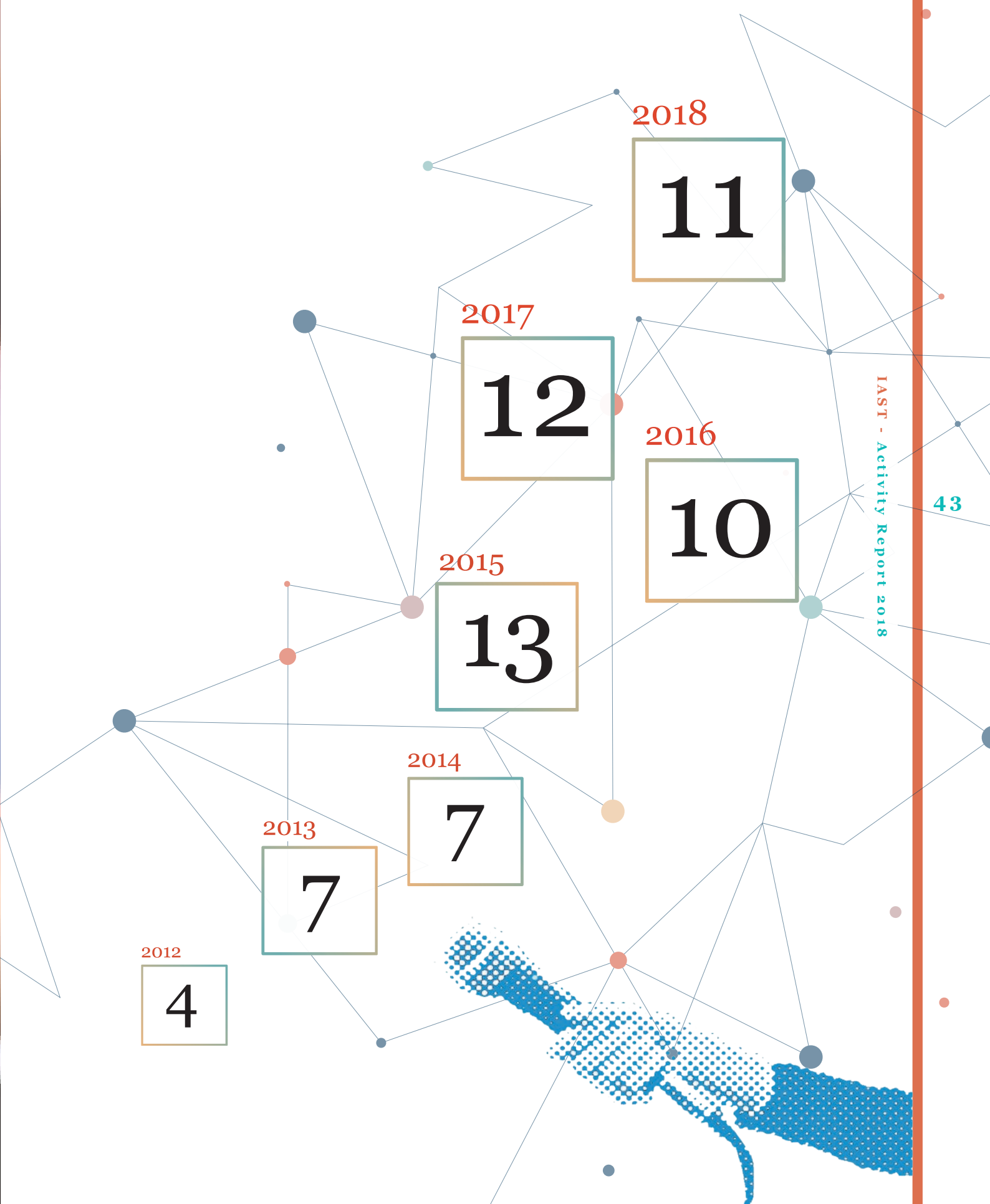

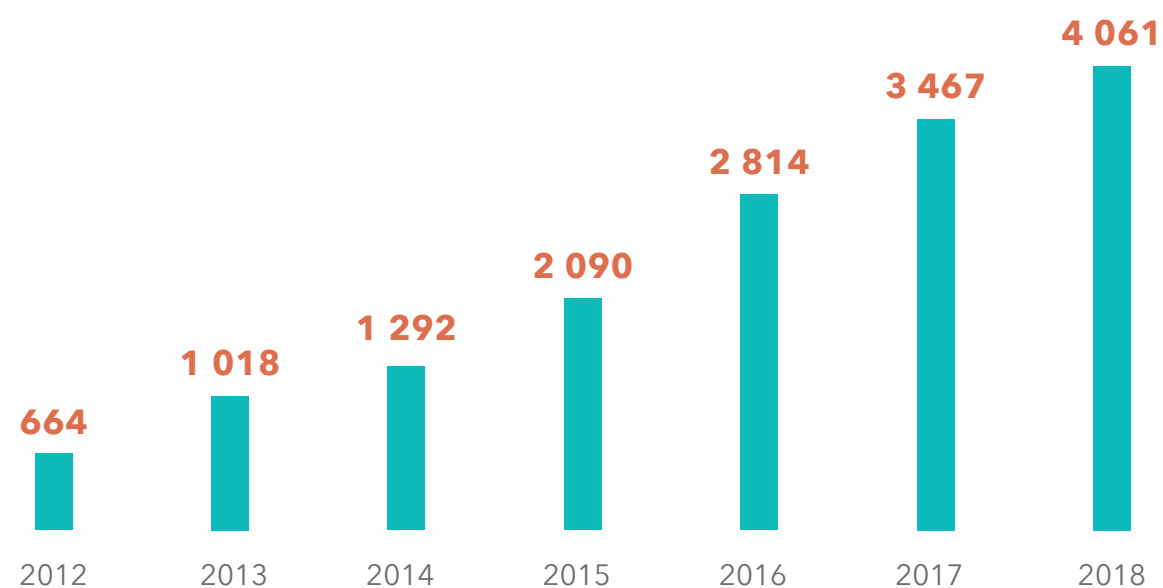
