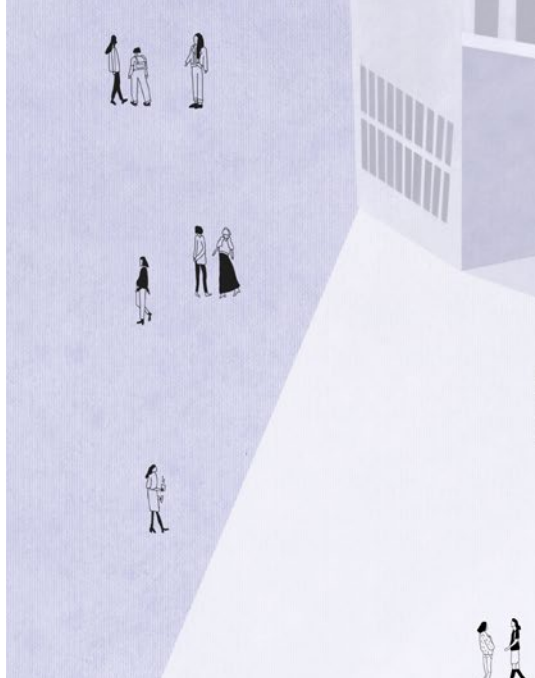
Writing from the perspective of lockdown in May 2020, the year 2019 seems already a long time ago. But it was an exciting and decisive year in the development of IAST. As well seeing as a rich range of research publications and activities, 2019 was the first full year of operation of our new funding arrangements as part of the Ecole Universitaire de Recherche (funded until 2028), which will see the integration of interdisciplinary research into the teaching of doctoral students. It saw the award of tenure to our first assistant professor in a subject outside of economics (many congratulations to Jonathan Stieglitz).

It also saw our move into the magnificent new building which we share with TSE, and of which we occupy a central floor that facilitates our interaction not only across disciplines within IAST but also between IAST and TSE, some of whose members had been much less aware of our existence than they will be from now on. The architects, Yvonne Farrell and Shelley McNamara, received architecture's most prestigious award, the Pritzker Prize, within a few months of our moving in, and we can all attest to the impact of their innovative approach to space on our ways of working and communicating.

It has been a great wrench to retreat into Zoomland so soon after getting used to the pleasure of our new physical environment, and 2020 will bring challenges we never imagined even at the end of 2019. But the strength of the institution is its people, and they continue undaunted by the difficulties of remote working. It is my pleasure to present you this report from a more innocent, virus-free era, secure in the knowledge that the originality, energy and determination of our researchers and staff will make 2020 a year no less to be proud of than its predecessor.

IAST GOVERNANCE

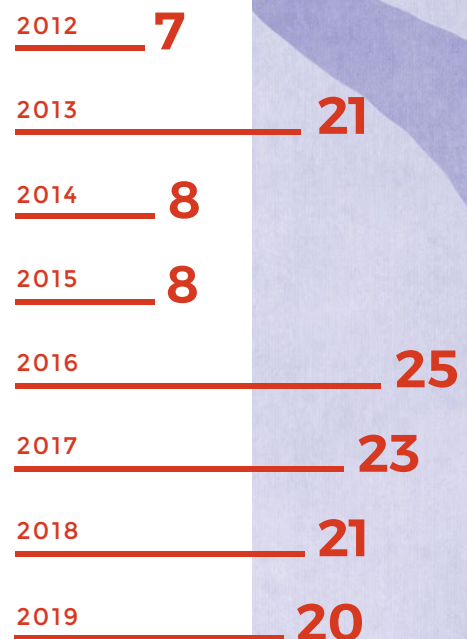
IAST operates as a sheltered foundation under the aegis of the Jean-Jacques Laffont - TSE Foundation.

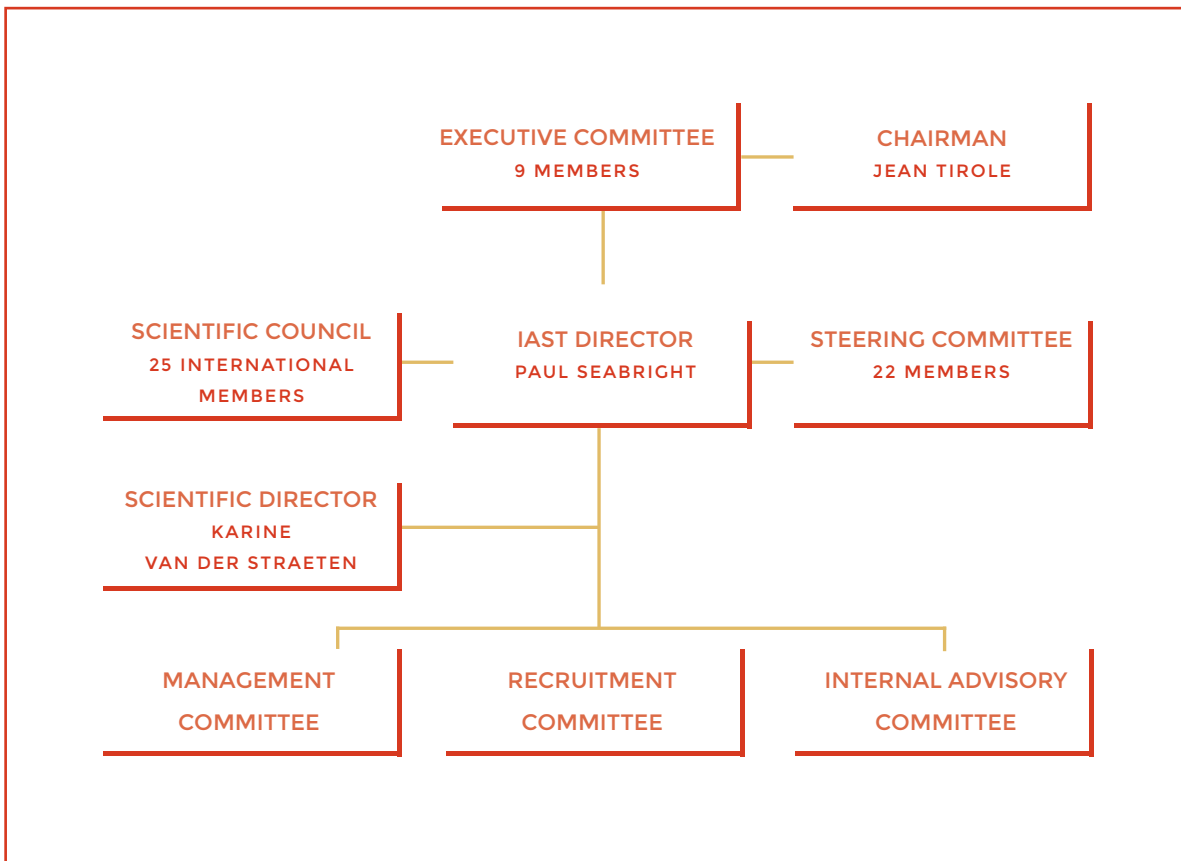
IAST has a scientific council composed of 25 members and is governed by an Executive Committee (COMEX) with representatives of the Toulouse Capitole University, the Jean-Jacques Laffont - TSE Foundation including IAST researchers, the collegium of public partners and the collegium of economic partners. IAST is directed by Paul Seabright, who is assisted by Delphine Pouts; the IAST administration is directed by Joël Echevarria and the IAST scientific director is Karine Van Der Straeten.

In June 2019, François Bourguignon, director of EHESS, Chief Economist & Senior Vice President of the World Bank in Washington and former director of Paris School of Economics succeeded Jean Tirole as chairman of the new IAST executive committee, helping develop IAST alongside TSE.

The Institute for Advanced Study in Toulouse is a unified scientific project whose broad aim is to study human behavior through an innovative and multidisciplinary approach to social science. Our Institute is home to a team of resident full-time researchers from leading universities worldwide. While most researchers specialize in using analytical and quantitative methods to address their scientific questions, some researchers utilize both qualitative and quantitative methods, while others use only qualitative methods. The Institute welcomes a large network of visitors from >25 countries, and partners with economists and mathematicians at the Toulouse 1 Capitole University, INRAE, CNRS and the Toulouse School of Economics. They focus their research on ecological, bio-behavioral and demographic aspects of human variation within the frameworks of human adaptability and evolution. They employ a wide range of methods common to the life, social and behavioral sciences, including observational fieldwork, biomedical surveillance, field and laboratory experiments, analysis of secondary datasets, and theoretical modeling.

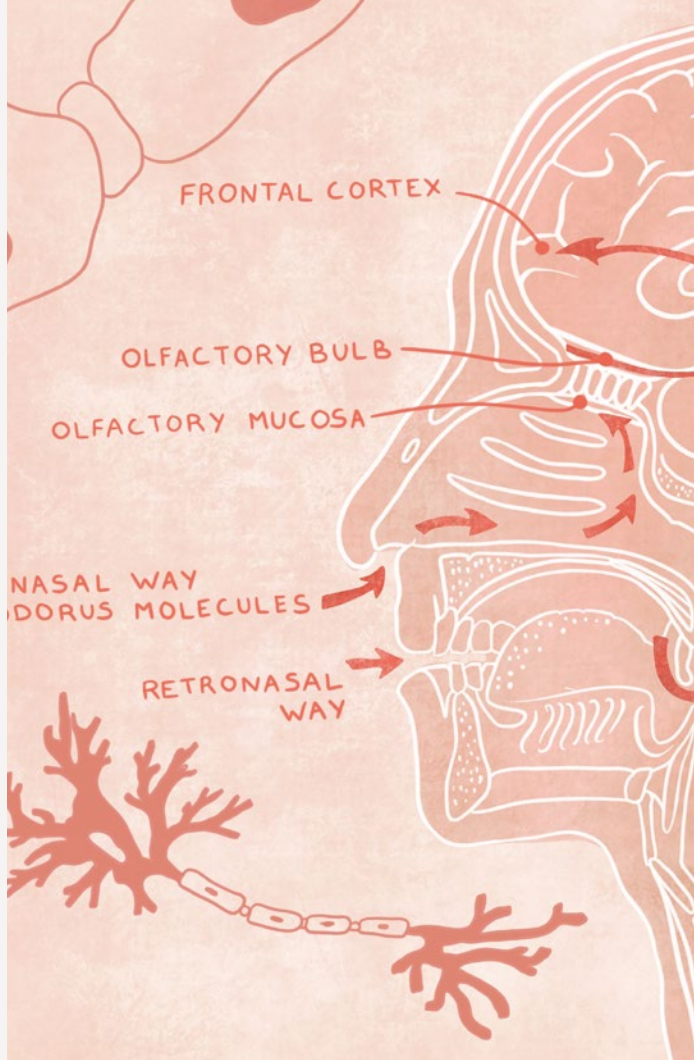

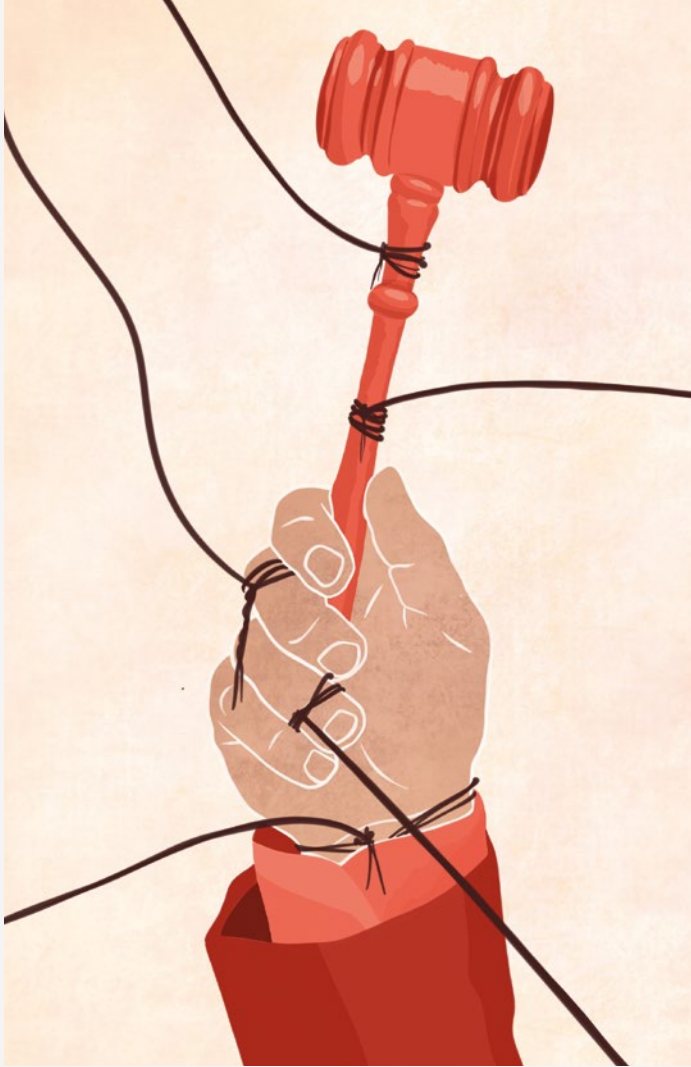

As lead PI of DE JURE (data and evidence for judicial reform), Daniel Chen has been running law and development RCTs (Randomized Controlled Trials) through relationships with a large number of governments in addition to their world bank personal relationships.

An estimation of around 17 countries benefit today from these randomized impact evaluations to improve justice, a few examples follow:

- Estonia is deploying a digital democracy RCT using quadratic voting for survey research and has a data ecosystem interconnected via their X-roads system.
- Chile uses within-dashboard RCTs to leverage insights from social preference economics, telework/court congestion-pricing RCTs, and mobile e-justice RCTs.
- Peru focuses on RCT of training judges from theory to case-based (possibly based on the history of their past decisions).
- In Kenya, there is an adaptive learning of RCT.
- Brazil has probably the best data ecosystem because it's already linked to the employer-employee registry; here is RCT of legal analytics to firms.
- India and Croatia participate in the collection of data.
- Bangladesh deploys an RCT app (developed by a previous Harvard student of Pr. Chen) to prevent gender-based violence.
- Pakistan and Serbia are at discussion.

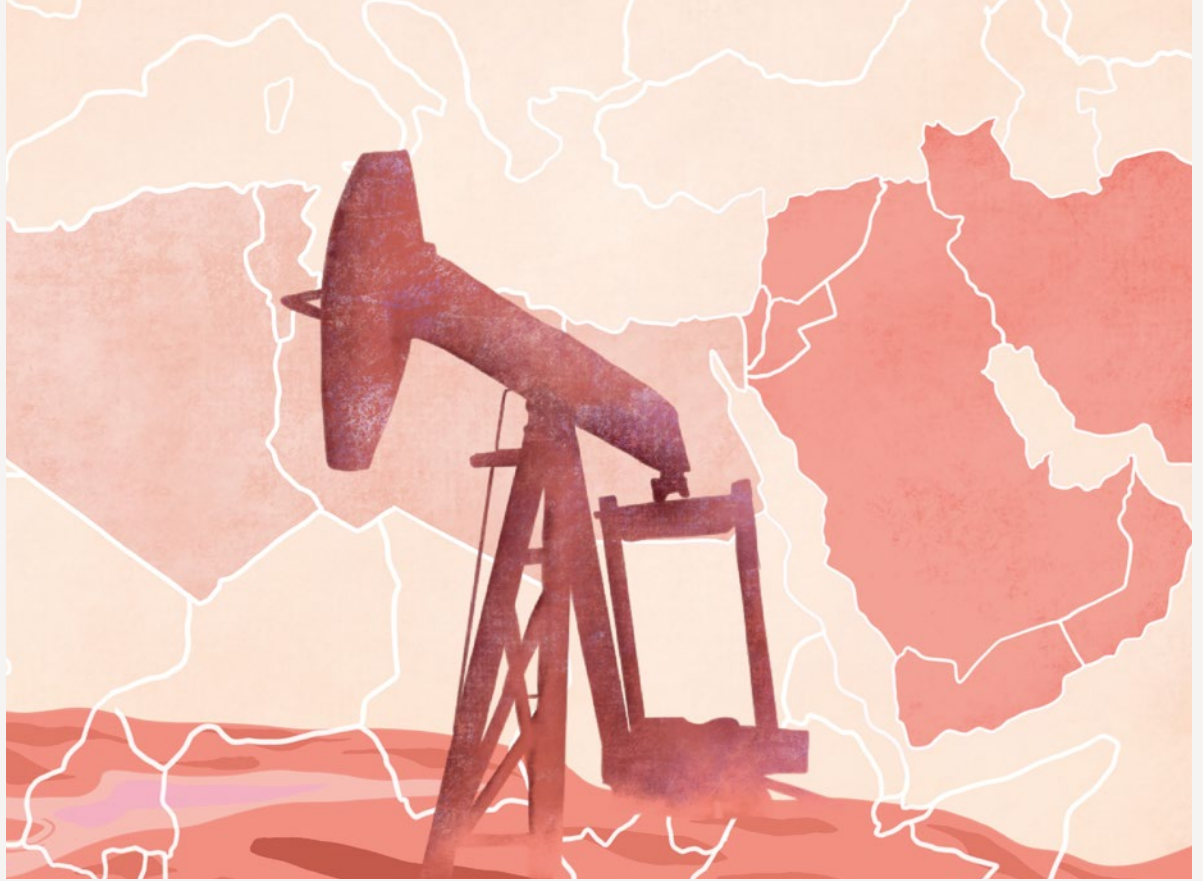

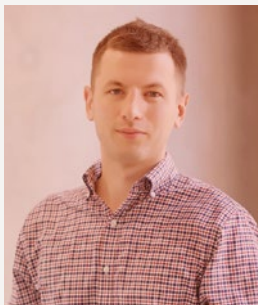

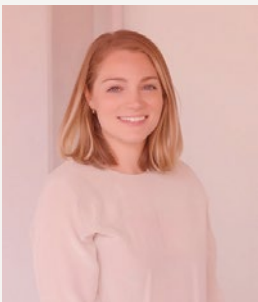

OUR SCIENTIFIC COMMUNITY MOVES TO A NEW CAMPUS

In November 2019, >300 researchers and administrative staff members moved buildings, from the 18th century Manufacture des tabacs to the new TSE-IAST building. Located in the historic center of Toulouse at the confluence of the Garonne River and Canal de Brienne, the forward-thinking masterpiece envisioned by Grafton architects was designed to maximize interactions between IAST and TSE researchers. The building was designed for cross-fertilization of ideas between resident researchers and visitors. As a testament to the new building's architectural excellence, in March 2020, building architects Yvonne Farrell and Shelley McNamara received the Pritzker Architecture Prize in recognition of their talent, vision and commitment in the genesis of major contemporary university buildings. This marks also a historic advance as there have only been three previous female laureates in the more than 40 year history of the prize, two of them in mixed teams.

The new building's construction is inspired by the typical reddish-brick architecture of Toulouse, which is often referred to as the "Pink City". The six-story building offers panoramic views over the Brienne Canal, the Garonne river and the Saint-Pierre churches. Features include an impressive sky cloister, an enhanced medieval rampart, 11,280 sqm of office space for ~350 faculty members, staff and PhD students, three state-of-the-art conference auditoriums, six seminar rooms and meeting rooms on each floor. Both traditional and modern, the edifice is designed to high energy-efficiency standards, including an innovative air-cooling system using water from the

Brienne canal.

A quarter of a century after Jean-Jacques Laffont's initial steps toward the endeavour of what was to become the Toulouse School of Economics, today his fellow members carry out his mission in a new building with the intention of fostering pioneering scientific exchanges, organizing cross-frontier academic events, and inviting the general public to delve into the world of social science.

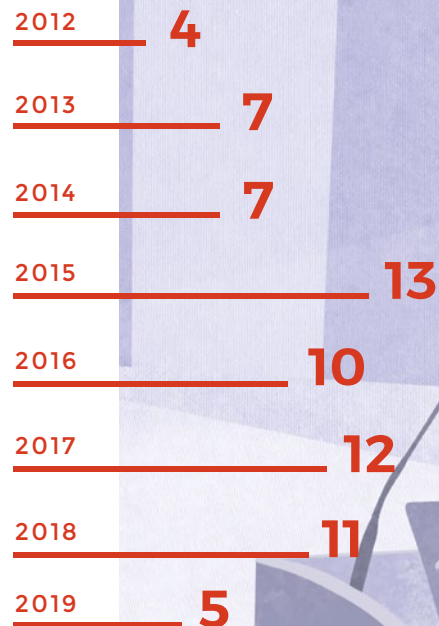

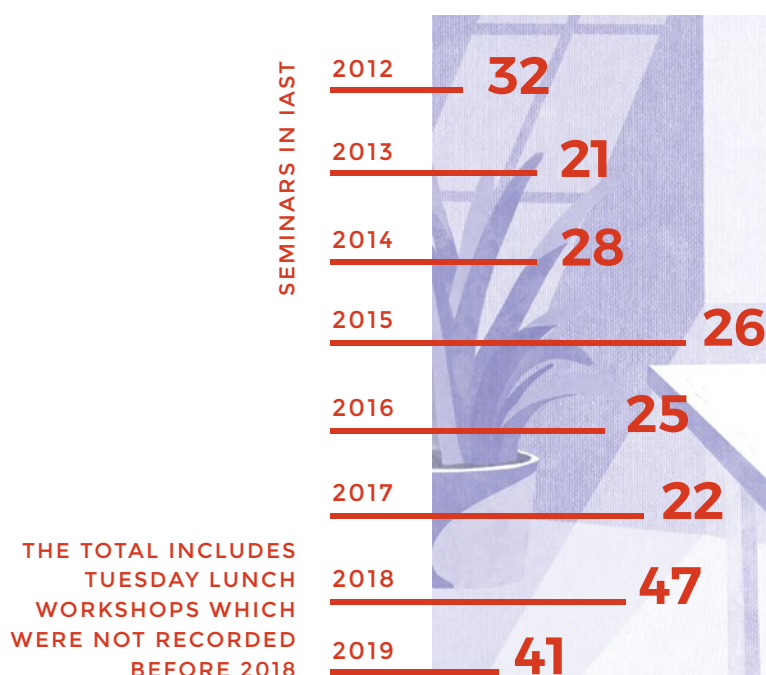

The campaign aimed at encouraging the French to change their eating habits and observe the impact of these changes, it was supported by 500 personalities in France and by several environmental and animal welfare NGOs. 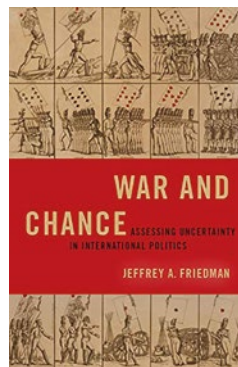

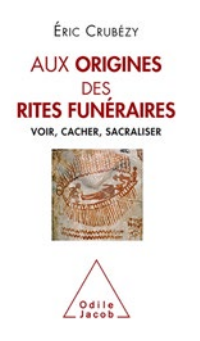

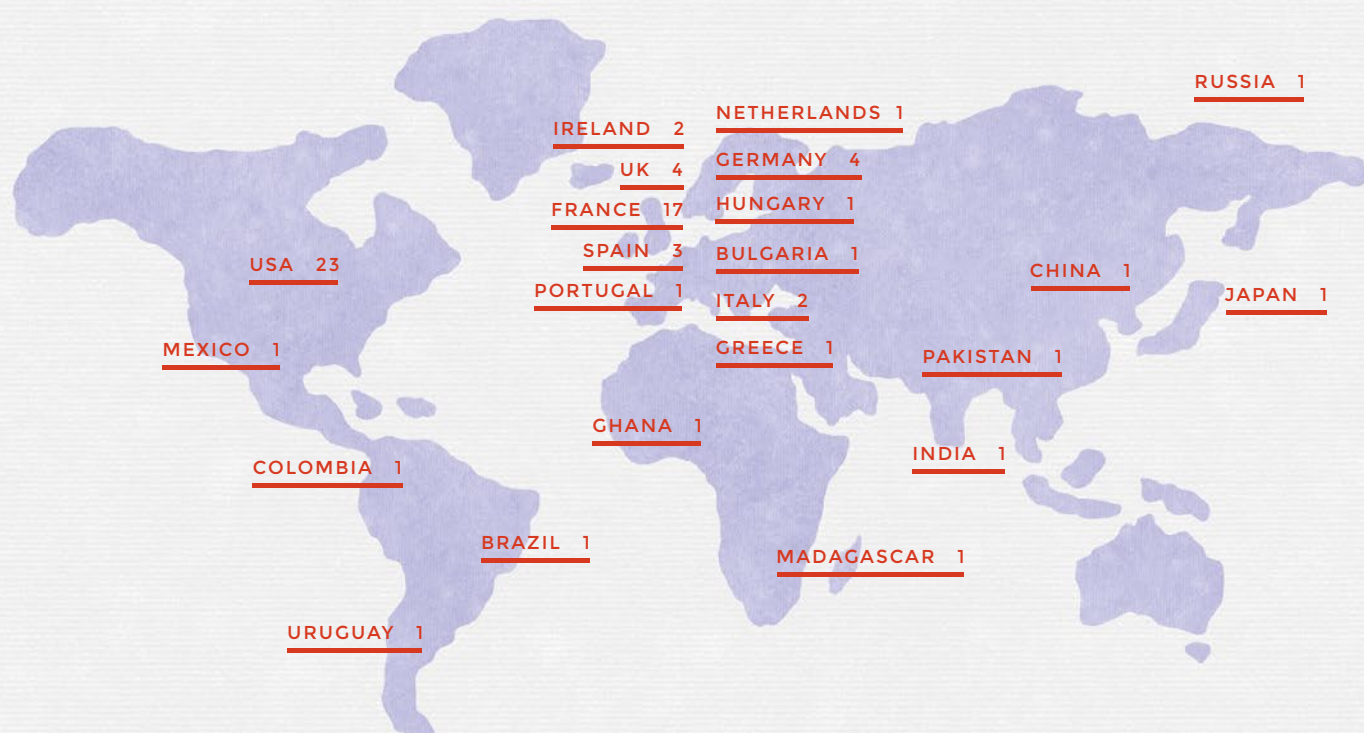
