#### CONTENTS



2020 was an enormously challenging year for all academic institutions. But it posed particular challenges to IAST's way of working, based as this has been on a great deal of informal personal contact for open and flexible discussion, many in-person seminars and conferences, and a large number of international visitors. Meetings on video are a reasonable substitute for in-person presentations of fairly well advanced research results. But they are much less adequate for brainstorming and developing the kinds of unexpected perspective on which interdisciplinary research particularly relies.

It was also particularly disappointing for us to have to endure lockdown so soon after moving into our wonderful new building, so many of whose interesting spaces are conceived to as to facilitate the kinds of meeting that encourage free-ranging discussion. In the few weeks after we arrived in November 2019 it was clear that the meeting rooms and open spaces were filled with people, and it has been sad to think that we shall only recover that buzz again very gradually this year. However, our colleagues have been energetic and ingenious in finding alternative ways to communicate. And, as this report reveals, they have also been productive in research in spite of some very challenging personal and professional circumstances.

The pandemic has created especially severe obstacles to those researchers doing field research, many of whom have been unable to visit their field

sites and still do not know when they will be able to do so. Collaboration with local colleagues has enabled many projects to continue, but there will need to be creative reflection on the ways in which field projects are conceived and executed in the future, as some of the constraints brought about by the pandemic are unlikely to disappear soon.

As this report shows, our community has also responded quickly and creatively to the challenge of tackling important research questions raised by the pandemic, with contributions in a wide range of fields. Our members have been active in the press and in policy contexts, helping to maintain a high standard of evidence-based discussion of key policy challenges.

As we approach the 10th anniversary of IAST's foundation we are proud of the energy and originality of our researchers and are confident in our future as a world-class interdisciplinary research institution.


#### **IAST GOVERNANCE**

**IAST** operates as a sheltered foundation under the aegis of the Jean-Jacques Laffont - TSE Foundation.

IAST has a scientific council composed of 28 members and is governed by an Executive Committee (COMEX) with representatives of the Toulouse Capitole University, the Jean-Jacques Laffont - TSE Foundation including IAST researchers, the collegium of public partners and the collegium of economic partners. IAST is directed by Paul Seabright, who is assisted by Delphine Pouts; the IAST administration is overseen by Joël Echevarria and the IAST scientific Director is Ingela Alger since 1st September 2020. She replaced Karine Van Der Straeten who acted as scientific Director until 31st August 2020.

François Bourguignon (director of research emeritus at EHESS, former **Chief Economist & Senior Vice President** of the World Bank in Washington and former Director of Paris School of Economics) is the chairman of the IAST executive committee, helping develop IAST alongside its sister institute, the internationally renowned Toulouse School of Economics (TSE).

The Institute for Advanced Study in Toulouse is a unified scientific project whose broad aim is to study human behavior through an innovative and multidisciplinary approach to social science. Our Institute is home to a team of resident full-time researchers from leading universities worldwide. While most researchers specialize in using analytical and quantitative methods to address their scientific questions, some researchers utilize both qualitative and quantitative methods, while others use only qualitative methods. The Institute welcomes a large network of visitors from >25 countries, and partners with economists and mathematicians at the Toulouse 1 Capitole University, INRAE, CNRS and the Toulouse School of Economics.





IAST prides itself on its wide and active network of international academics that visit and interact with our Toulousebased community. Inevitably, the number of physical visitors in Toulouse in 2020 was very low, due to the Covid-19 pandemic. However, seminars and conference were widely replaced by online events, attracting high audiences from all over the globe.



Five new research fellows joined the institute in September 2020, one funded by ANITI\* and four by IAST through its host University, Toulouse Capitole. The newcomers all work at the crossroads of disciplines and are already developing exciting new interdisciplinary research projects in Toulouse.

"Incarceration and its disseminations: COVID-19 pandemic lessons from Chicago's Cook county jail" was featured in 89 news outlets including Washington Post, New York Times, Wall Street Journal, The Economist, CNN, The Independent, US News & World Report, Politico, and Slate.

He also published an opinion piece in the Wall Street Journal on how releasing nonviolent accused makes us safer in Covid era.



"Since the outbreak of the coronavirus pandemic in the beginning of 2020, I have been working hard to publish an empirical paper related to Covid-19, analyzing the relationship between jailing practices and community infections.

I am also examining the impact of Covid-19 on access to justice in India, with the aim of providing valuable insights on the experience of marginalized groups including women, returning migrants and minorities - in criminal, domestic violence, and lockdown violation cases. Information may be shared with judges to facilitate better performance.



A press release was published on a study by researchers from IAST, Science Po Paris and the University of York on the French population during the 2020 March containment policies. Their study suggests that older people and women are more likely to adhere, whilst extroverts, and supporters of the far right and far left, may be more likely to rebel. As Covid-19 restrictions tighten around the world, their findings provide insights into the potential public response and can help to ensure that health measures are effectively targeted.

**Psychologists at IAST work with** researchers from anthropology, biology, computer science and economics to investigate human behavior across cultures, but also to investigate the behavior of non-human animals and intelligent machines.

Research topics in 2020 included how fake news propagate and how cultures evolve; how refugee parents care for and bond with their infants; how people perceive the minds of humans and machines; how people across the world think of morality, cooperation and punishment; and how human and non-human primates make risky decisions.

**Results from these collaborations provide** insights into the evolutionary roots of behavior, the struggles of contemporary humans, and the social-technological future of humanity.

#### **OVERVIEW**

- When does democracy work well for nearly all citizens?
- What do citizens need to know to be good citizens and to make sure that their interests and concerns are taken into account?
- How much inequality in resources, such as money and information, is compatible with equality in political representation?
- How is information and representation shaped by the internet?
- Are there new institutional remedies to deal with failures of democratic representation?

This workshop addressed these fundamental questions about the functioning of twenty-first century democracy, as numerous countries face populist challenges to existing representative institutions and grapple with the role of social media and the

internet in mass politics. In particular, the event probed the relationship between political information and its distribution throughout the political society and the quality of democracy and the distribution of political power.

Special attention was paid to the interaction between the articulation of clear and plausible principles of democracy and the development of empirical research. This is based on the belief that a closer dialogue between political philosophy and empirical or positive social science research is needed to gain deeper insights, more clearly speak to public debates, and identify neglected areas for future research.



"Political scientists and political philosophers can learn much from each other. Political scientists are interested in understanding how to measure and explain how well the political world lives up to the ideal of political equality. Philosophers spend a lot of time trying to understand what this ideal of equality consists in and how to realize it. The IAST provides a splendid opportunity to bring these complementary concerns together in a mutually advantageous way."

#### **COVID-19 RESEARCH**

'We had to adapt to the pandemic at dizzying speed' **Paul Seabright** 



2020 posed a formidable challenge for the social sciences. Researchers had to try to rapidly understand a major upheaval in our societies - from the way a tiny pathogen has spread across the globe, wreaking havoc on our bodies, to the way individual and social defense mechanisms have disrupted our normal lives. At the same time, we were all confined to our homes for much of the time, and severely limited in our ability to go out and observe the world the rest of the time.

Fortunately the same connected world that facilitated the spread of the virus also greatly helped our response to it. If international airline networks did much to speed the epidemic, the internet has enabled international collaboration in a vast range of fields, as well as remote data collection by researchers. The work of IAST anthropologist Jonathan Stieglitz in facilitating a coordinated policy response to the threat posed by Covid-19 to indigenous communities in the Amazon is a telling example, since Jonathan was unable to interact with these communities in person.



The Covid-19 pandemic has required a dizzying speed of adaptation and we will still be figuring out how to respond for some years to come. Here are just a few examples of the many research initiatives developed in 2020 by IAST researchers on some very up-tothe-minute questions about how our societies are responding:


